All,

Below is a proposed schedule for the remainder of the 2019 IRP. Note that some of the dates have passed already. Also note that there is not much flexibility in the schedule. Staff is requesting a 7-calendar day turnaround for discovery, though we can be flexible during holiday weeks. The Special Public Meeting date of February 25 is the earliest possible date for a public meeting, so I do not think we can flexibly make this any earlier.

If people can get back to me on the schedule **no later than COB Monday**, I would appreciate it. Unless parties feel a need for a prehearing conference call to discuss this proposed schedule, Staff can file a motion with the ALJ to amend the procedural schedule.
