Thank you for participating in yesterday afternoon's workshop – it was productive, and we appreciate your valuable contributions to the conversation.

Given the conversation yesterday – here is what we are thinking in terms of next steps –

- June 26: Revised Draft rules circulated
- July 10: final informal redlines requested, along with any written comments you wish to provide
- Week of July 15: Final Workshop before formal rulemaking phase
- July 30: public meeting to move to the formal phase (Formal phase being the Commission-led process of final rule consideration, where we have a formal public comment hearing, publish rules with the secretary of state, and have Commissioners consider adoption of rules at a public meeting. All of the dates for these events would be set after July 30th)

I will be combining proposed edits in a revised draft, and will send that out to everyone on the 26th.
